NOTICE OF SUBMITTAL OF ORDINANCES

TO: THE RESIDENTS AND PROPERTY OWNERS OF KALAMAZOO CHARTER TOWNSHIP, KALAMAZOO COUNTY, MICHIGAN AND ANY OTHER INTERESTED PERSONS:

PLEASE TAKE NOTICE that the following is a summary of two Ordinances which were submitted to the Charter Township of Kalamazoo Board for first reading at its regular meeting of October 8, 2018. The Ordinances are scheduled for adoption on October 22, 2018. A summary of each Ordinance follows:

**PROPOSED ORDINANCE NO. 605
ZONING ORDINANCE TEXT AMENDMENTS**

SECTION I. AMENDMENT TO ARTICLE 2.00 GENERAL PROVISIONS. Amends Section 2.03 C. 3, by adding subpart “a” and subpart “b” regarding detached accessory buildings size requirements and exceptions. Subpart “b” includes a table that sets limitations for aggregate gross floor areas, maximum heights and setback requirements for accessory buildings on large parcels.

SECTION II. EFFECTIVE DATE, SAVINGS CLAUSE AND REPEAL. The Ordinance is effective 8 days after publication of a summary thereof, after adoption. Conflicting ordinance provisions are repealed. Pending prosecutions are saved.

**PROPOSED ORDINANCE NO. 606
ZONING ORDINANCE TEXT AMENDMENTS**

SECTION I. AMENDMENT TO SECTION 14.02 “PERMITTED USES AND STRUCTURES”. Makes packaged liquor sales in the RM-2 District Zoning Classification a special use.

SECTION II. AMENDMENT TO ARTICLE 8 “SITE DEVELOPMENT STANDARDS”. Amends Article 8.00 Site Development Standards, Section 8.02 Scope of Requirements, by adding subsection WW, which places certain conditions on the retail sales of Package Liquor in the RM-2 District Zoning Classification.

SECTION III. EFFECTIVE DATE, SAVINGS CLAUSE AND REPEAL. The Ordinance is effective 8 days after publication of a summary thereof, after adoption. Conflicting ordinance provisions are repealed. Existing prosecutions are saved.
